ELIGIBILITY BASED ON ANNUAL HOUSEHOLD INCOME

- **\$50,000 or less for Families** (married couple, or person with at least one dependent, for example, a single parent or grandparent with guardianship)
- **\$25,000 or less for Individuals**
- **If you pay rent, taxes or heating bills but are not working you may still be eligible for some tax credits.**

Unless noted, sites are walk-in, first-come first-serve and may fill up before the official closing time.

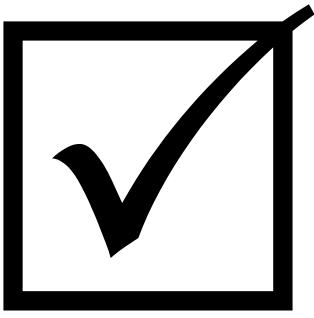

CHECK LIST:

WHAT TO BRING TO GET YOUR TAXES AND CREDITS PREPARED

IDENTIFICATION/SOCIAL SECURITY NUMBERS

- ID: Driver's License or State ID
- Proof of Social Security numbers for yourself, spouse and each dependent

INCOME STATEMENTS OR FORMS

- A copy of last year's return, if available
- Wages (*all Forms W-2*)
- Unemployment (*Form 1099-G*)
- Pension (*Form 1099-R*)
- Social Security (*Form SSA-1099*)
- Supplemental Security Income (SSI), Letter from SSA
- Interest/Dividends (*Form 1099-INT or 1099-DIV*)
- DHS Assistance (*DHS Annual Statement*)
- Child Support (*Child Support Annual Statement*)
- Gambling/Lottery Winnings (*Form W-2G*)
- Miscellaneous Income (*Form 1099-MISC*)
- Any other income documentation you may have

PROOF OF EXPENSES

- Energy Efficient Home Appliances and Improvements (*receipts should show Energy Star Rating*): insulation; windows; furnace; water heater; refrigerator; clothes washer; dishwasher
- Residential electric bills
- Medical or HMO Premiums paid for self and/or family members
- Dependent care expenses
- Student loan interest or tuition and course materials

AMOUNT OF ANNUAL HEATING COSTS

Call your heat provider and ask for your heating costs for the year. For 2010 taxes, the period will be 11/01/2009–10/31/2010. (This information can be found in your Dec., Jan., and Feb. statements.) *The Home Heating Credit is available for renters as well as homeowners.*

HOMEOWNERS

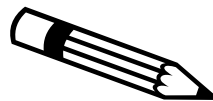
Taxable value of your home and the summer and winter property taxes bills for the tax year. *For the Michigan Homestead Property Tax Credit, bring a complete copy of your summer and winter property tax bills.*

RENTERS

Your lease or rental contract and rent receipts for the tax year, plus your landlord's name and address, *for the Michigan Homestead Property Tax Credit.*

FOR DIRECT DEPOSIT

Your bank or credit union name, routing number and account number. Direct deposit is the fastest and safest way to receive your refund.
